Membership Fees

Fees to be retained at current level. Proposal RK, Seconded LC. Passed unanimously.

Financial Policies

IT produced a series of financial policies. The meeting recommended a few amendments to these policies. The amended proposals are as follows:

FoIVFDF Accounting Policies

1. Administration

- a) That the treasurer maintains a current and deposit account.
- b) That two signatures be required for all account withdrawals and one for any inter account transfers.
- c) That there be at least 3 appointed signatories to the accounts who are not related/cohabiting/married to each other.
- d) That the deposit account contain all monies relating to the underwriting fund and that the current account contain all monies for the administration and ticket subsidy funds
- e) That IVFDF Information Point shall not under any circumstance be a signatory of the account.
- f) That the Treasurer submit accounts of FoIVFDF (or a summary of accounts) for inspection to the AGM once a year.

2. Membership, Fund Division and Distribution

- a) That the level of the membership levy be determined at Annual General Meeting each year.
- b) That membership (currently £6) be divided in 3 equal ways into ticket subsidy fund (currently £2/member), administration fund (currently £2/member) and underwriting fund (currently£2/member).
- c) That all interest from both accounts be paid to the underwriting fund (deposit account).
- d) That all donations go to the underwriting fund unless otherwise specifically stated by the donor.
- e) That money from the underwriting fund cannot be transferred to the administration fund or the ticket subsidy fund.

3. Underwriting

- a) That the recommendation as to the level of underwriting be determined by the Friends Committee each year on the basis of the funds available in the underwriting fund, but be in the region of between a third and a half the total sum of the underwriting fund each year.
- b) That, as per the FoIVFDF constitution, an IVFDF Representatives Meeting has final say over whether the amount previously determined is given an instance of the festival for the purposes of underwriting a limited loss.

4. Changes and Dissolution

- a) That changes to these polices be made at a General Meeting of FoIVFDF on a majority vote basis.
- b) That deviations from this policy are agreed by the committee and reported at the next General Meeting.

IT proposed these amended polices be accepted by the society. CP seconded. Passed unanimously.

Constitutional Changes

Discussion took place of constitutional changes which will be needed in the future.

Are we meeting our aims?

Discussion took place on how we were meeting our aims. IT expressed concern that most of the money in the underwriting fund was from individual donations, and therefore not generated by the friends as such.

Underwriting for Future Festivals

IT proposed we offer underwriting of up to £400 for both Exeter and UEA, subsequent upon ratification by an IVFDF reps meeting, and providing that they submit a budget at our request. Seconded by AP. Passed unanimously.
